

Service for Residential Customers with Electric Vehicles

The following are the Medical Baseline rates associated with service under Schedule EV-TOU-5-P. This is SDG&E's residential rate for customers with an electric car or use electricity to run a natural gas home fueling pump who also choose to manage their electric costs by reducing their use when an event is called. The car must be registered with the California Department of Motor Vehicles.
